BE IT REMEMBERED that at a Regular Meeting of the Commissioners' Court of Johnson County, Texas, held on the 8th day of October A. D. 1945, the following members were present: Honorable Roy Anderson, County Judge, Commissioner Wyatt, Precinct #1, Commissioner Hadley, Precinct #2, Commissioner Maddox, Precinct #3, Commissioner Roland, Precinct #4, and A. T. Griffin, County Clerk. Among other things they did the following:

A motion was made by Commissioner Wyatt and seconded by Commissioner Maddox that the Treasurer's Report be approved. Commissioners Wyatt, Hadley, Maddox and Roland voted "Aye".

A motion was made by Commissioner Wyatt and seconded by Commissioner Roland that all properly approved accounts be allowed and ordered paid. Commissioners Wyatt, Hadley, Maddox and Roland voted "Aye".

A motion was made by Commissioner Wyatt and seconded by Commissioner Maddox that the bond of W. J. Spell as Public Weigher be approved. Commissioners Wyatt, Hadley, Maddox and Roland voted "Aye".

A motion was made by Commissioner Wyatt and seconded by Commissioner Maddox that the bond of Alford J. Jackson as Public Weigher be approved. Commissioners Wyatt, Hadley, Maddox and Roland voted "Aye".

A motion was made by Commissioner Wyatt and seconded by Commissioner Roland that the following agreement for furnishing Right of Way for Highway No. FM 110 be approved:

THE STATE OF TEXAS () COUNTY OF JOHNSON () WHEREAS, it has come to the attention of the Commissioners' Court of Johnson County, Texas, in Regular session on this the 8th day of October 1945, that the Texas Highway Department will order a location made on Highway No. FM 110, from Cleburne to Grandview provided Johnson County, through its Commissioners' Court, agrees and obligates itself before location is made to fulfill the following requirements, on location approved by the Texas Highway Department, without cost to the State: (1) Provide clear title to the following, with standing timber: a minimum of 100 foot right-of-way, lands for borrow sources, and right-of-way for such drainage facilities as may be required, such title to be in the name of the State of Texas; (2) remove all obstructions and encroachments except standing timber; and (3) do the fencing.

IT IS, THEREFORE, ORDERED THAT Johnson County, acting herein by and through its Commissioners' Court, agrees and obligates itself, before location is made, to fulfill the following requirements at its own expense and without recourse on the State for any costs or other obligations incurred thereby:

(1) Provide clear title to the following, with standing timber: a minimum of 100 foot right-ofway, lands for borrow sources, and right-of-way for such drainage facilities as may be required, such title to be in the name of the State of Texas.

(2) Remove all obstructions and encroachments except standing timber; and

(3) Do the fencing; on Highway No. FM 110, from Cleburne to Grandview on location approved by the Texas Highway Department.
