Also the valuation on the W1/2 of lot 3, block 248 in the City of Cleburne be cancelled and reassessed on the valuation to accept \$76.15 in full settlement of all taxes against the same. Also for the valuation on W part of lot 4 in Block 247 of the City of Cleburne to be cancelled and to be reassessed on the valuation to accept \$189.08 in full settlement of taxes against the same. Commissioners Wyatt, Hadley, Maddox and Roland voted "Aye".
