IT IS, THEREFORE, ORDERED BY THE COMMISSIONERS' COURT OF JOHNSON COUNTY, TEXAS:

- 1. That said election was duly called; that notice was given in accordance with law and in accordance with the order calling the election; that the election was held in accordance with law; that due return of said election has been made by the proper officers; that a majority of the resident, qualified voters of said District voting at said election have voted for the Fresh Water Supply District.
- 2. That in the matter of the petition of I. H. Bandy and thirteen others praying for the establishment of a Fresh Water Supply District as in said petition described and designated as Johnson County Fresh Water Supply District No. 1; be it known that an election was called for that purpose in said District and held on the 12th day of November, 1960, and a majority of the resident, qualified voters voting thereat voted in favor of the creation of said District. Now, therefore, it is ordered by the Court that a Fresh Water Supply District be and the same is hereby established under the name of Johnson County Fresh Water Supply District No. 1, with the following metes and bounds:

Byers Survey, Abstract No. 30 and the Northeast corner of the Eli M. Thomason Survey, Abstract No. 827; Thence in a Westerly direction with the common boundary of said Byers and Thomason Surveys a total distance of 1,600 feet (more or less) to a point on the West right-of-way line of the G. C. & S. F. Railroad for a corner; Thence, in a southerly direction with West right-of-way line of the G. C. & S. F. Railroad a total distance of 1,500 feet (more or less) to the Northeast corner of the Mrs.

- 5. That a certified copy of this order shall constitute a certificate of election, and that the County Clerk is hereby authorized and directed to cause a certified copy of such to be mailed to each of the Supervisors and the Tax Assessor and Collector declared to be elected herein.
