From end of F.M. Road 2435, 5.6 miles north of Godley, North to Tarrant County line, a distance of approximately 3.7 miles.

We further solemnly swear that we have read and understand the provisions contained in the Constitution and Laws of this State relative to the valuation of taxable property, and that we will faithfully perform all the duties required of us under the constitution and Laws of this State.
