Make conference room out of existing hall which is west of men's lounge.

Install vinyl abostos tile on floor. Close up hall on south end at column with partition of sheetrock and 2x4 framing. Paint walls and ceiling of conference room.

4. Build concrete ramp at north entrance of basement, with water drain connected to existing floor drain. Install aluminum pipe hand rail on west side of ramp. Replace top concrete step. Extend concrete floor 30" north from west entrance door. 275.00

6. Storerooms:

Build storeroom in east side of basement under stairway. Build storeroom in west side of basement under stairway. Each one would have one 3'x6'8" door unit with lock. Outside of partitions would be 3/8" plywood. Framework would be 2x4 material. One pull chain light would be installed in each storeroom. Outside of partitions would be painted to match existing wall and woodwork would be finished to match existing. One storeroom would cost 175.00 or two for 350.00 If the marble wainscoat is install on front part of the
