when the following business was transacted:

Commissioner Roland introduced an order and moved its adoption. The motion was seconded by Commissioner Coward and carried by the following vote: AYES: Commissioners Coward, Bryant, Boteler, and Roland. NOES: None.

The order thus adopted as follows:

WHEREAS, it is necessary for Johnson County Roads, to improve the public roads within said County, and to purchase rights-of-way for the public roads within said County, and that time warrants be issued by said County to

pay all or any part of the cost of said machinery, equipment, improvements and rights-of-way; and

WHEREAS, the Commissioners' Court of Johnson County wishes to authorize the giving of notice of intention to issue said time warrants; Therefore

BE IT ORDERED, ADJUDGED AND DECREED BY THE COMMISSIONERS' COURT OF JOHNSON COUNTY, TEXAS:

SECTION 1:

That it is hereby found and declared that it is necessary to purchase machinery and equipment for the construction and/or maintenance of County roads, to improve the public roads within said County, and to purchase rights-of-way for the public roads within said County, and that in order to accomplish the same it is necessary that time warrants of the County be issued to pay all or any part of the cost of said machinery, equipment, improvements and rights-of-way.

That the County Judge is hereby authorized and directed to cause notice in substantially the following form to be published as required by law:

That the County Judge is hereby authorized and directed to cause notice in substantially the following form to be published as required by law:

NOTICE OF INTENTION TO ISSUE TIME WARRANTS

TO THE QUALIFIED VOTERS OF JOHNSON COUNTY, TEXAS, WHOSE NAMES APPEAR ON THE LAST APPROVED TAX ROLLS AS PROPERTY TAXPAYERS OF SAID COUNTY, AND TO ALL OTHER INTERESTED PERSONS:

NOTICE IS HEREBY GIVEN that it is the intention of the Commissioners' Court to authorize and issue time warrants of the County in the maximum sum of \$250,000.00, bearing interest at a rate not to exceed six per cent (6%) per annum, and maturing serially over a period of years not to exceed 15 years from their date with maximum maturity date not later than October 1, 1981, for the purpose of evidencing the indebtedness of said County for all or any part of the cost of purchasing machinery and equipment for the construction and/or maintenance of County roads, improving the public roads within said County and purchasing rights-of-way for the public roads within said County. It is the intention of said Commissioners' Court to pass the order authorizing the issuance of said time warrants at a regular meeting to

be held on the 12th day of September, 1966, at the Johnson County Courthouse in Cleburne, Texas, at ten o'clock a.m.
