A motion was made by Commissioner Atwood and seconded by Commissioner Boteler that all bills against Johnson County be allowed and ordered paid as presented, examined in open court and properly endorsed.

A motion was made by Commissioner Boteler and seconded by Commissioner Roland with motion passing unanimously the Commissioners' Court of Johnson County hereby authorizes the Commissioner shown below to use County employees and equipment to construct and/or maintain a private road within his precinct as shown below, as authorized by Article 6821b, Texas Statutes, to-wit:
