BE IT REMEMBERED AT A REGULAR MEETING OF THE COMMISSIONERS' COURT in and for Johnson County, Texas, on the above mentioned date at the Courthouse at Cleburne, Texas, with the following members present: Thomas E. Ball, County Judge, C. W. Atwood, Commissioner of Precinct No. 1, W. R. Bryant, Commissioner of Precinct No. 2, W. I. Boteler, Commissioner of Precinct No. 3, M. W. Roland, Commissioner of Precinct No. 4, Louis B. Lee, County Clerk, Lorene Moreland, County Auditor, John MacLean, County Attorney, Marshall Young and O. B. Hadley.

A motion was made by Commissioner Roland and seconded by Commissioner Atwood that all bills against Johnson County be allowed and ordered paid as submitted, examined in open court and properly endorsed.

All voted aye.

A motion was made by Commissioner Bryant and seconded by Commissioner Atwood with motion passing unanimously the Commissioners' Court of Johnson County hereby authorizes the Commissioner shown below to use County employees and equipment to construct and/or maintain a private road within his precinct as shown below, as authorized by Article 6821b, Texas Statutes, to-wit:

A motion was made by Commissioner Atwood and seconded by Commissioner Boteler to authorize Tax Assessor-Collector to purchase five National Cash Register machines from Hallman Printing & Office Supply, at a cost of \$735.00 each, to be paid out of next year's budget.

All voted aye.

A motion was made by Commissioner Roland and seconded by Commissioner Boteler that Earl Travis be employed to put Christmas lights on top of courthouse, and that he be paid \$75.00 for this service.

All voted aye.

A motion was made by Commissioner Roland and seconded by Commissioner Boteler that we request refund for the property damage insurance which the County bought and paid for, less any adjustment of property damage claims which have already been paid.

All voted aye.

A motion was made by Commissioner Boteler and seconded by Commissioner Roland the Glen Mitchell be authorized to accept bids for Counter in District Clerk's Office, and use his own judgment in accepting lowest bid.

All voted aye.

A motion was made by Commissioner Roland and seconded by Commissioner Atwood that the bid of Sherwin-Williams for carpeting the District Clerk's Office at price of \$600.00 be accepted.

All voted aye.

There being no further business, Court is hereby adjourned.
