BE IT REMEMBERED AT A REGULAR MEETING OF THE COMMISSIONERS' COURT IN AND FOR JOHNSON COUNTY, TEXAS, on the above-mentioned date at the courthouse in Cleburne, Texas with the following members present: Thomas E. Ball, County Judge; C.W. Atwood, Commissioner Precinct No.1; O.B. Hadley, Commissioner Precinct No.2; W.I. Boteler, Commissioner No.3; B.B. Aldridge, Commissioner Precinct No.4; Joe L. Townes, County Clerk.

The invocation was given by Commissioner Atwood.

Order of the Court to have the County attorney to write a letter to E.L. Tarver instructing that the fence across county road #805D be removed.

A motion was made by Commissioner Boteler and seconded by Commissioner Atwood to pay the current and accumulated telephone bill for the constable of Precinct #2; after the bill is paid to have the telephone disconnected.

All voted aye.

A motion was made by Commissioner Aldridge and seconded by Commissioner Atwood to discontinue paying any office rent for the Constable of Precinct #2 effective March 1, 1973 and that a copy of this action be mailed to Constable W.H. Gregory, Joshua, Texas.

The following commissioners voted "aye: C.W. Atwood; W.I. Boteler; and B.B. Aldridge Commissioner O.B. Hadley voted "no."

A motion was made by Commissioner Boteler and seconded by Commissioner Hadley to pay \$1,000.00 retainer's fee per year to Garrett Morris, Attorney, Tarrant County, for his services in representing Johnson County on highway matters affecting Johnson County, Texas.

All voted aye.

A motion was made by Commissioner Boteler and seconded by Commissioner Hadley to authorize Glen Mitchell to attend the annual conference of Civil Directors on February 26 and 27, 1973; subject to the approval of Dennis McWilliams, County Tax Assessor-Collector.

All voted aye.

A motion was made by Commissioner Atwood and seconded by Commissioner Boteler to approve County Treasurer's report beginning October 1, 1972.

All voted aye.

A motion was made by Commissioner Atwood and seconded by Commissioner Hadley to approve the bond of Trittes Birdwell, County Juvenile Officer.

All voted aye.

A motion was made by Commissioner Atwood and seconded by Commissioner Aldridge to authorize the County Agent to spend an amount not to exceed \$100.00 for repairs to the spraying machine used by his department.

All voted aye.

A motion was made by Commissioner Atwood and seconded by Commissioner Boteler to authorize the County Judge to enter into a joint agreement with the Atlantic Richfield Company and American Telephone and Telegraph in relocating their lines along Farm to Market Road #3211.

All voted aye.

A motion was made by Commissioner Boteler and seconded by Commissioner Aldridge to award the First National Bank of Cleburne, Texas the County Depository for this years 1973 and 1974 as follows:

A motion was made by Commissioner Atwood and seconded by Commissioner Boteler to authorize National Southwest Boiler Company to repair radiators in the courthouse at a cost of \$25.00 per radiator.

A motion was made by Commissioner Hadley and seconded by Commissioner Boteler to appoint Mrs. Elizabeth Pope as County Court Reporter effective February 16, 1973 to replace Aloma Williams, resigned.

All voted aye.

A motion was made by Commissioner Atwood and seconded by Commissioner Aldridge to approve payment of the monthly bills.
