Ball, County Judge; C.W. Atwood, Commissioner Precinct No.1; O.B. Hadley, Commissioner Precinct No.2; W.I. Boteler, Commissioner No.3; B.B. Aldridge, Commissioner Precinct No.4 and Joe L. Townes, County Clerk.

The invocation was given by Commissioner O.B. Hadley.

A motion was made by Commissioner Atwood and seconded by Commissioner Boteler to approve the County Treasurer's report for the period beginning 7-1-73 and ending 9-30-73.

A motion was made by Commissioner Atwood and seconded by Commissioner Aldridge to adopt the following resolution.

This is a joint project.
