BE IT REMEMBERED AT A REGULAR MEETING OF THE COMMISSIONERS" COURT IN AND FOR JOHNSON COUNTY, TEXAS, on the above-mentioned date at the courthouse in Cleburne, Texas with the following members present: C.C. "Kit" Cooke County Judge; Commissioner Precinct No.1 C.W. Atwood ; Commissioner Precinct No.2 O.B. Hadley ; Commissioner Precinct No.3 W.I. Boteler ; Commissioner Precinct No.4 B.B. Aldridge and Joe L. Townes, County Clerk.

The invocation was given by Judge C.C. Cooke.

Mr. Truett Bailey Sr. appeared before the Court relative to the seriousness of the increasing wolf population in Johnson County and the need for a county trapper. The Court agreed to check into the matter and attempt to try to work out a solution to the problem.

A motion was made by Commissioner Aldridge and seconded by Commissioner C.W. Atwood to establish the office of Medical Examiner for Johnson County and to appoint Dr. Arthur L. Raines as the Medical Examiner for Johnson County. Dr. Raines was officially sworn in by Judge C.C. "Kit" Cooke.

All voted aye.

Henry Wayne Shaw, newly appointed Juvenile Probation Officer, was officially sworn in by Judge C.C. Cooke and introduced to the Court.

The upcoming appointments to the following Committees were discussed by the Court: County Planning Commission, Rural Fire Commission, Hospital Board and Salary Grievance Committee.

A letter was received from George W. Marti, Mayor of Cleburne, concerning proposed Airport at Joshua as follows"

A motion was made by Commissioner Atwood and seconded by Commissioner Hadley to pay \$400.00, 3rd year lease on Christmas decorations around the Courthouse and to approve payment of 15% of the original cost of the decorations to obtain permanent ownership which is the last and final payment.

All voted aye.

No action was taken by the Court on the notification of Mr. Jack Martin that a portion of Pecan Plantation will be opened in Johnson County.

A motion was made by Commissioner Hadley and seconded by Commissioner Boteler to approve the plat of Paradise Park, Section I, Sub-division Johnson County.

All voted aye.

A motion was made by Commissioner Boteler and seconded by Commissioner Atwood to approve the Resolution accepting minute order No. 70690 as follows:

A motion was made by Commissioner Atwood and seconded by Commissioner Boteler to approve the bonds of Dr. Arthur Raines, County Medical Examiner, and Henry W. Shaw, County Juvenile Probation Officer, each for one year.

All voted aye.

A motion was made by Commissioner Aldridge and seconded by Commissioner Atwood to approve the deputation of Quincy Charles Hauk, Jr. as Reserve Deputy Sheriff.

All voted aye.

A motion was made by Commissioner Boteler and seconded by Commissioner Hadley to increase travel pay allowance from 12¢ to 16¢ per mile effective Jan. 1, 1976.

All voted aye.

A motion was made by Commissioner Aldridge and seconded by Commissioner Atwood to pay the County Court Bailiff \$12.00 per day.

All voted aye.

A motion was made by Commissioner Aldridge and seconded by Commissioner Atwood to increase the Septic Tank Inspection fee from \$20.00 to \$30.00 - the County to retain \$10.00 and the inspector to receive \$20.00 effective 1/1/76.

All voted aye.

A motion was made by Commissioner Boteler and seconded by Commissioner Atwood to correct the minutes of Dec.8, 1975 to read as follows: Solicitors not allowed in the Courthouse unless a charitable non-profit organization or on official County business.

All voted aye.

A motion was made by Commissioner Boteler and seconded by Commissioner Atwood to approve the minutes as read with the exception of solicitation in the Courthouse which is to be corrected in the Jan. 2, 1976 minutes.

All voted aye.

A motion was made by Commissioner Boteler and seconded by Commissioner Atwood to approve payment of bills as read by the County Auditor.

A motion was made by Commissioner Hadley and seconded by Commissioner Atwood to adjourn.
