A motion was made by Commissioner Atwood and seconded by Commissioner Hadley to accept the offer of Sheriff Stuart Huffman to vacate the living quarters at the County Jail to afford additional office space: in turn the court agrees to employ an additional full time dispatcher in order that the jail will be manned twenty four house a day seven days a week the year round.

A motion was made by Commissioner Hadley and seconded by Commissioner Atwood to authorize the County Auditor to advertise for bids on a squad car for the Sheriff's Department based upon specifications approved at the meeting of the Commissioner Court on March 1, 1976 amended to read minimum 350 cubic inch V 8 engine".

Boteler to authorize the payment of repairs on typewriter for the Highway Patrol

Office at Alvarado.

Aldridge to authorize Fay Tackett, Veteran Service Officer, attendance at the

Annual Veterans Service Officer's Conference to be held in Waco, Texas March 1819, 1976.

Hadley to amend the 1976 budget to include an increase of \$900.00 for the Johnson

County Historical Survey Committee.

Mr. Noble Clark of Burleson appeared before the Court recommending that the Kimbro Clinic not be purchased by the County.

Mr. Russell Lace and Maurice Sheppard of Burleson appeared before the Court commending then on protecting the county tax dollar and also expressed their concern on renovating the present Jail to meet State Jail Standards instead of constructing of new facility.

A motion was made by Commissioner Atwood and seconded by Commissioner Hadley to approve minutes as read.

A motion was made by Commissioner Aldridge and seconded by Commissioner Atwood to approve bills as read by the County Auditor.

- Prec. #2: 1. Extend C.R. 704 from highway 174 to F.M. road 2280.
 2. C.R. 1016 from Tarrant County line from highway 731 to intersect with F.M. 1902
- Prec. #3: 1. From highway 67 to F.M. 1807. CR 527 & 602 from 35 W to old CR 600

Prec. #4: 1. F.M. 1807 to F.M. 2258 (East Route)

2. F.M. 1807 to F.M. 2258 (West Route)

A motion was made by Commissioner Atwood and seconded by Commissioner Aldridge to install 220 wiring in District Clerk's Office and change photo machine from Xerox to Piney Bowes and to purchase a new typewriter for the Tax Office. The cost of typewriter not to exceed \$425.00.
