BE IT REMEMBERED AT A REGULAR MEETING OF THE COMMISSIONER'S COURT IN AND FOR JOHNSON COUNTY, TEXAS, on the above-mentioned date at the Courthouse in Cleburne, Texas with the following members present: C.C. Cooke County Judge; Commissioner Precinct No.1 C.W. Atwood; Commissioner Precinct No.2 O.B. Hadley; Commissioner Precinct No.3 W.I. Boteler; Commissioner Precinct No.4 B.B. Aldridge and Joe L. Townes, County Clerk.

Invocation was given by W.I. Boteler.

The final plat of Caddo Peak Estates Phase I was not approved by the Court.

A motion was made by Commissioner Boteler and seconded by Commissioner Aldridge to authorize the County Auditor to advertise for bids on 5 C.B. Radio's for the State Dept. of Public Safety Highway Patrol cars stationed in Johnson County.

All voted aye.

A motion was made by Commissioner Atwood and seconded by Commissioner Hadley to refer to the County Attorney for a legal opinion the petition of Pat Kendrick to incorporate a new city.

All voted aye.

Mrs. Judy Broom Rt. 1 Box 558, Joshua did not appear in reference to improving County Road 705.

A motion was made by Commissioner Boteler and seconded by Commissioner Atwood to approve the preliminary plat of Martin Acres West off C.R. 711 Prec. 3.
