BE IT REMEMBERED AT A REGULAR MEETING OF THE COMMISSIONER’S COURT IN AND FOR JOHNSON COUNTY, TEXAS, on the above-mentioned date at the Courthouse in Cleburne, Texas with the following members present: C.C. Cooke County Judge; Commissioner Precinct No.1 C.W. Atwood ; Commissioner Precinct No.2 O.B. Hadley ; Commissioner Precinct No.3 W.I. Boteler ; Commissioner Precinct No.4 B.B. Aldridge and Joe L. Townes, County Clerk.

Invocation was given by Commissioner Atwood.

The Court adjourned to the Southwest corner of the Courthouse yard for the dedication of a monument commemorating Bi-Centennial Year. The dedication was made by Judge Cooke.

Court re-convened at 9:15 A.M. in the County Court Room.

A motion was made by Commissioner Boteler and seconded by Commissioner Aldridge to go on record favoring the Johnson County Rescue Unit project as presented by John Scott. Final acceptance of the project will be determined by the amount of money raised by the rescue personnel.

A motion was made by Commissioner Atwood and seconded by Comm. Hadley to approve purchase of grappling hooks for the Johnson County Civil Defense Director, Glen Mitchell, at a cost of \$100.00.

A motion was made by Commissioner Atwood and seconded by Comm. Hadley to approve the following contract and agreement between the City of Grandview and the Commissioners Court of Johnson County subject to the approval of the County Attorney.
