Atwood, Commissioner of Precinct No.1, O.B. Hadley, Commissioner of Precinct No.2, Loyd H. Reese, Commissioner of Precinct No.3, B.B. Aldridge, Commissioner of Precinct No.4, Tommy Altaras, County Judge and Joe L. Townes, County Clerk.

Invocation was given by O.B. Hadley.

A motion was made by Commissioner Hadley and seconded by Commissioner

Atwood to approve the bond in the amount of \$5,000.00 for Lavern Collins,

Assistant Juvenile Probation Officer

All voted aye.

A motion was made by Commissioner Atwood and seconded by Commissioner Reese to approve the County Treasurers' quarterly report for the period beginning April 1, 1978 and ending June 30, 1978.
