District Judge, C.C. "Kit" Cooke, 249<sup>th</sup> District Court presented the Court a check for Six Thousand (\$6,000.00) Dollars from the Adult Probation Department Surplus fees.

County Attorney, Dan W. Boulware, withdrew his request for a supplemental payment from the County for an Assistant District and County Attorney. He stated that the funding for this project had been acquired from another source.
