A motion made by Commissioner Russell to approve the hiring of two deputies for the Sheriff's department; Malcom Southerland and William F Brinker and seconded by Commissioner Roe.

A motion was made by Billy Roe to request that cities have large trash pickup twice a year instead of once a year; to request a change in the law regarding trash dumping from Class C misdemeanor to a class B if items in trash has someone's name then it is presume that this is the person who dumb the trash; to amend subdivision rules to require subdivision to tell how they are going to handle trash collections and second by Commissioner York.
