10. JOHNSON COUNTY LAW ENFORCEMENT CENTER

Motion was made by Comm. Roe, seconded by Comm. Miller, to approve hiring Childress and Recer Engineering firm to do a drainage study on the property where the new Johnson County Law Enforcement Center is being constructed.

Motion was made by Comm. York, seconded by Comm. Miller, to approve the minutes as written of the meetings of January 18, 26, and 29, and February 1 and 8, 1988.

1. SASHA MEADOWS II

Motion was made by Comm. Harmon, seconded by Comm. York, to approve a revision of Lots 3R and 4R of the Sasha Meadows subdivision into Lots 3R-1 and 4R-1.

2. WHISPERING MEADOWS II

Motion was made by Comm. Harmon, seconded by Comm. York, to approve the revision of the re-plat of Lots 54-R-1, 54-R-2, and 54-R-3 of the Whispering Meadows, Section II, subdivision, into Tract 54, Lots 54-1-R, 54-2-R, and 54-3-R.
