BE IT KNOWN that on this the 11th day of April, 1988, the Honorable Commissioners' Court of Johnson County met in the Courthouse in the City of Cleburne in a regular session with all members present and considered the following:

APPROVAL OF BILLS

Motion was made by Comm. Roe, seconded by Comm. Harmon, to approve paying the bills as presented by the Auditor.

All voted aye; motion passed.

CONSIDERATIONS

1. JOHNSON COUNTY LAW ENFORCEMENT CENTER

Motion was made by Comm. Roe, seconded by Comm. Harmon, to approve the Bob Moore Construction Company substituting a Firestone adhered roofing system instead of a standing seam metal roof for the Law Enforcement Center at no additional cost.

All voted aye; motion passed.

RECESS

Commissioners went into recess at 9:15 a.m.

Commissioners reconvened into open court at 9:25 a.m.

CONSIDERATIONS

8. COUNTY CLERK'S OFFICE

Motion was made by Comm. Miller, seconded by Comm. Roe, to approve the construction of a small office in the basement of the County Clerk's office at an estimated cost of \$3,500.00 to \$4,000.00.

All voted aye; motion passed.

7. REQUEST OF COUNTY CLERK TO JOIN NATIONAL ASSOCIATION OF CLERKS

Motion was made by Comm. Harmon, seconded by Comm. Miller, to approve the County Clerk joining the International Association of Clerks, Recorders, Election Officials, and Treasurers, with the County paying his dues of \$90.00 per year.

All voted aye; motion passed.

6. REQUEST OF COUNTY CLERK AND ONE DEPUTY TO ATTEND SEMINARS

Motion was made by Comm. Harmon, seconded by Comm. Miller, to approve the County Clerk and one of his deputies attending the District and County Clerks' State Convention on June 20-25, 1988, in Corpus Christi and to approve the Clerk and one deputy attending the Probate School on May 5-6, 1988, in Austin.

All voted aye; motion passed.

5. BRIDGE REPLACEMENT PROGRAM OF DEPARTMENT OF HIGHWAYS AND PUBLIC TRANSPORTATION

Motion was made by Comm. Miller, seconded by Comm. Roe, to approve Johnson County participating in the 1987-91 Off State System Federal Aid Bridge Replacement and Rehabilitation Program on County Road 482 at Mustang Creek for total project cost of \$52,800.00; on County Road 399, bridge replacement at East Buffalo Creek for estimated total cost of \$145,200.00; on County Road 270, bridge replacement at Village Creek for estimated total cost of \$69,600.00, with the County Auditor being authorized to issue checks for the County's participation when required.

All voted aye; motion passed.

9. JOB TRAINING PARTNERSHIP ACT

Motion was made by Comm. Roe, seconded by Comm. Miller, to approve the North Central Texas Council of Government's Memoranda of Agreement on the Job Training Partnership program.

All voted aye; motion passed.

10. ADVERTISING FOR BIDS

Motion was made by Comm. Roe, and seconded by Comm. Harmon, to advertise for bids on property insurance and automobile insurance.

All voted aye; motion passed.

11. PURCHASES FROM \$1,000.00 TO \$5,000.00

Motion was made by Comm. Harmon, seconded by Comm. Miller, to approve the Commissioner of Precinct No. 1 purchasing two surplus State of Texas trucks at an estimated cost of \$3,700.00 each, one used tank car that would be used for a culvert at an estimated cost of \$3,500.00 and to repair the transmission on a motor grader estimated to cost over \$1,000.00 and less than \$5,000.00.

2. WATERSRIDGE ESTATE, PHASE 1

Motion was made by Comm. Miller, seconded by Comm. Harmon, to approve the County assuming maintenance of the Watersridge Estate, Phase 1, subdivision, with the roads having been maintained by the developer for at least two years after the completion of said roads.

All voted aye; motion passed.

APPROVAL OF MINUTES

Motion was made by Comm. Harmon, seconded by Comm. Roe, to approve the minutes of the Commissioners' Court meeting of March 28, 1988, as written.

2. REQUEST OF JUVENILE OFFICER TO ATTEND SEMINAR

Motion was made by Comm. Harmon, seconded by Comm. Miller, to approve Susan Musick, a Juvenile Probation Officer, attending a Juvenile Probation Officers' Seminar in Austin on May 9-13, 1988.

All voted aye; motion passed.

4. REQUEST OF COUNTY COURT AT LAW JUDGE ATTENDING SEMINAR

Motion was made by Comm. Roe, seconded by Comm. Miller, to approve Tommy Altaras, the County Court at Law Judge, attending the Texas College for Probate Judges Seminar on May 5-6, 1988, in Austin.

All voted aye; motion passed.

3. REQUEST OF SHERIFF'S OFFICE FOR DEPUTIES TO ATTEND SEMINARS

Motion was made by Comm. Harmon, seconded by Comm. Miller, to approve two deputies attending a Domestic Violence Seminar at the Regional Police Academy in Arlington on May 4-6, 1988; for one deputy attending an Interrogation Seminar on June 20-22, 1988; for two deputies attending a Basic Supervision Seminar on July 18-22, 1988; and for two deputies attending a seminar on Terrorism on September 19-21, 1988 at Regional Police Academy in Arlington.

All voted aye; motion passed.

Motion was made by comm. Harmon, seconded by Comm. Roe, to approve two Sheriff's deputies attending the Basic Police Juvenile Officer Training School in Austin on April 25-29, 1988, with the County Auditor advancing them the expense funds in an estimated amount of \$435.00; the two deputies being required to furnish receipts to the County Auditor for actual expenses and required to refund any amount that is not actually used for expenses up to \$435.00.

All voted aye; motion passed.
