# 1. CAMBRIDGE PARK

#### 2. HOMESTEADS

Mr. Banton, as Chairman of the sub-committee studying the Veteran's Administration using eh old hospital building, will be acting as the County's agent during this meeting.

# 9. REPLACEMENT OF CULVERTS ON COUNTY ROADS

Motion was made by Comm. Harmon, seconded by Comm. Miller, for the County to adopt the standard of a minimum size of 18" diameter by 20' long for culverts for driveways connecting to county roads or a greater diameter as may be required by the County Commissioner or Quality Control office due to drainage requirements. The County Commissioner in that precinct has the option of granting an exception for a smaller diameter culvert if

the drainage and topography of the land would so require. The adoption of this standard on minimum size of culverts would apply to new driveways being installed or existing driveways that are re-worked or that cause drainage problems that need to be corrected. A County Commissioner can install a culvert fro a driveway at the minimum cost of \$100.00 and \$5.00 per foot for culverts over 20 feet in length when he has the men and the equipment available to do so. The property owner is responsible for paying for the culvert and the cost of installing it whether a private contractor or the County Commissioner installs the culvert.

All voted aye; motion passed.
