1. JOHNSON COUNTY LAW ENFORCEMENT CENTER

A progress report was made by Frank Neal, Engineer, and Danny Butler, Construction Manager, on the construction of the Law Enforcement Center.

No action was taken.

APPROVAL OF BILLS

Motion was made by Comm. York, seconded by Comm. Miller, to approve the bills as presented by the County Auditor.

All voted aye; motion passed.

SUBDIVISIONS

1. CO. RD 707-A (ROAD CLOSING)

Motion was made by Comm. Miller, seconded by Comm. Harmon, to approve the closing of County Road 707-A, which is approximately 5/10ths of a mile long and is located between County Road 707 and County Road 810, pursuant to the petition for the closing of this road signed by D.M. Johnson and J. B. Linville and all other adjoining land owners to County Road 707-A.

All voted aye; motion passed.

2. RICHLAND ESTATES (ASSUME ROAD)

Motion was made by Comm. Miller, seconded by Comm. Harmon, that the County not assume the maintenance of the roads in the

Richland Estates subdivision, because the roads were not built to County standards at the time of their construction.

3. HUDSON ESTATES (FINAL PLAT)
