A motion was made by Comm. Miller, seconded by Comm. Estes, to approve paying Johnson County Plumbing \$7,000.00 for the installation of the grease trap at the Law Enforcement Center.

AERIAL PHOTOGRAPHS FOR 9-1-1 ADDRESSING SYSTEM

A motion was made by Comm. Miller, seconded by Comm. Hewlett, to approve paying \$30,358.00 for the balance owed on the aerial photographs for the 9-1-1 addressing system to Air Surveys by Toler.

SUBDIVISIONS
