#### APPROVAL OF BILLS

A motion was made by Comm. Estes, seconded by Comm. Hewlett, to approve paying the bills as presented by the County Auditor, and to approve the County Auditor paying the Indigent Health Care bills subject to the County Auditor checking and approving those bills to be sure that they conform to the State Law on the provision of Indigent Care.

All voted aye; motion passed.

#### PURCHASES FROM \$1,000.00 to \$10,000.00

A motion was made by Comm. Harmon, seconded by Comm. Estes, to approve the Commissioner of Prec. #4 purchasing a used pickup truck, an air compressor and impact wrench; and the Commissioner of Prec. #1 purchasing an air compressor, with each of these items costing over \$1,000.00 and under \$10,000.00.

## WILSON ESTATES - ASSUME ROAD MAINT. - PREC. #2

A motion was made by Comm. Harmon, seconded by Comm. Miller, to approve the County accepting maintenance of the roads in the Wilson Estates Subdivision that have been maintained by the developer for at least two (2) years since the roads were completed in the subdivision.
