# LAND ACQUISITION OF RELOCATION OF PRECINCT #1 BARN

A motion was made by Comm. Harmon, seconded by Comm. Estes, to approve authorizing Comm. Hewlett, to commence proceedings to sell the present Prec. #1 land and barn at a minimum of \$147,000.00 and also to enter into negotiations concerning the purchase of a possible substitute location.

### LINE ITEM BUDGET AMENDMENT

A motion was made by Comm. Harmon, seconded by Comm. Estes, to approve the Line Item Budget Amendment for the County Attorney's Office, from the salary fund to equipment, to purchase an intoxilyzer, for use in the Northern part of Johnson County at a cost of \$6,314.00 (the City of Burleson will lease and maintain it); and to purchase a video camera at a cost of \$1,700.00 to be placed in the DPS vehicles, to be leased and maintained by the DPS at a nominal fee.
