A motion was made by Comm. Harmon, seconded by Comm. McFall, to approve the minutes of the Commissioners' Court meeting for August 23, 1993, and September 13, 1993.

PEARL ADDITION (ASSUME ROAD MAINTENANCE) - PCT. #3
