Thompson, to approve authorizing a reimbursement to Larry Ray Caplinski as reimbursement of a \$150.00 bond fee and \$88.00 in lost wages, being \$11.00 per hour for 8 hours, for a total of \$238.00. This being based on Mr. Caplinksi's arrest on a warrant that should have been recalled.
