BE IT KNOWN that on the 24th day of February, 1997 the Honorable Commissioners Court of Johnson County, met in Regular Session at 8:30 a.m., with all members present in the Courthouse in the City of Cleburne, Johnson County, Texas, and following the Invocation and the Pledge of Allegiance, the following items were considered:

V. PRECEDING BUSINESS

1. PUBLIC HEARING ON PROPOSED RULES FOR ADDITIONAL RESTRICTIONS ON DANGEROUS DOGS

BE IT KNOWN that on the 24th day of February, 1997 the Honorable Commissioners Court of Johnson County, Texas met in Public Hearing, at 8:30 a.m., with all members present in the courthouse, in the City of Cleburne, Johnson County, Texas with notice being posted in the Times-Review, Sunday, February 9, 1997, with no public opposition.

a. Committee Report

Committee Members are Roger Harmon, County Judge; Bill Moore, County Attorney; Sheriff Bob Alford; Jimmy Johnson, Chief Deputy and his staff; Lieutenant Bobby Lay; and Jim Simpson, Assistant County Attorney. Commissioner Ron Harmon gave a report.

b. The Proposed Rules for Additional Restrictions on Dangerous Dogs

Bill Moore gave a report on Additional Restrictions being proposed on Chapter 822 in the

Health and Safety Codes. Re-stated, not a leash law. These Additional Restrictions are for Unincorporated Areas of Johnson County.

c. Required Funding to Implement the Enforcement of the Additional Restrictions on Dangerous Dogs

Judge Harmon, gave a report on the Cost of Implementing this program. Hiring one deputy with benefits, \$23,411.84 annually, Grade 12; hiring one clerk with benefits \$14,815.53 annually, Grade 4; total personnel costs \$38,227.37. Equipment and related cost: one truck \$7,400.00; markings on truck, \$375.00; radio for truck \$467.00; siren box \$209.99; light box \$169.99; light bar \$569.98; siren speaker \$89.99; 2 wire cages \$278.00; one 8ft. Humane Dog Snare, \$57.00; one dart gun \$350.00 with shipping and handling \$150.00; one additional phone line \$300.00. The total cost for Equipment and related items \$10,416.95. The grand total cost for implementation of this program will be \$48,644.32.

The Commissioners Court closed the Public Hearing.
