BE IT KNOWN that on the 3rd day of June, 1997, the Honorable Commissioners Court of Johnson County, met in Special Session, with all members present, in the Courthouse, in the City of Cleburne, Johnson County, Texas, at 8:35 a.m., and the following items were considered:

RESOLUTION - 1998 CRIMINAL JUSTICE DIVISION GRANT APPLICATION,
COUNTY ATTORNEY INVESTIGATOR/LIAISON OFFICER

A motion was made by Comm. Harmon, seconded by Comm. Carpenter to approve the change in the wording of the Resolution 1998 Criminal Justice Division Grant Application, County Attorney Investigator/Liaison Officer to say that: "And that in the event of lost or misuse of the Criminal Justice Division Funds, the governing body, being Johnson County, assures that the funds will be returned to the Criminal Justice Division in full."

All voted aye, motion passed.

BE IT KNOWN that on the 3rd day of June, 1997, the Honorable Commissioners Court of Johnson County met in Executive Session with all members present, in the Courthouse, in the City of Cleburne, Johnson County, Texas in accordance with Texas Local Government Code Sec. ⁵51.074-Personnel Matters, Tax Office at 8:40 a.m.

A motion was made by Comm. Thompson, to approve the pay raise for Judy Tuttle, and to hire a part-time bookkeeper; but due to a lack of a second the motion died.

1. Judy Tuttle

A motion was made by Comm. Thompson, seconded by Comm. McFall, to raise Judy Tuttle's salary from \$21,396.00 to \$22,831.00.

All voted aye, motion passed.

2. Peggy Hinton

A motion was made by Comm. Harmon, seconded by Comm. McFall to approve the raise for Peggy Hinton, Tax Clerk I at \$13,687.00 to Tax Clerk IV at \$16. 608 .00.

All voted aye, motion passed.

3. Part-time Bookkeeper

A motion was made by Comm. Thompson, seconded by Comm. Carpenter to approve the hiring of a part-time Bookkeeper at the rate of \$10.00 per hour with a maximum of twenty-one (21) hours per week.

All voted aye, motion passed.

There being no further business before the Court concerning this Agenda, the Court adjourned on the same date at 9:05 p.m.
