BE IT KNOWN THAT on the 11th day of May, 1998, the Honorable Commissioners Court of Johnson County, Texas, met in regular Session at 9:00 a.m. with all members present in the Courthouse, in the City of Cleburne, Johnson County, Texas, and following the Invocation led by Roger Harmon, County Judge for Johnson County and the Pledge of Allegiance, the following items were considered:

V. PRECEDING BUSINESS

1. APPROVAL OF BILLS

A motion was made by Comm. McFall, seconded by Comm. Carpenter to approve the bills as submitted by the County Auditor.

All voted aye, motion passed.

2. ACKNOWLEDGMENT OF RECEIPT OF THE COUNTY AUDITORS REPORT AND THE COUNTY AUDITORS MONTHLY REPORT TO THE COURT

The County Judge, Roger Harmon, acknowledged the receipt of the County Auditors Report and the County Auditors Monthly Report to Commissioners Court.

3. PROCLAMATION FOR EMERGENCY MEDICAL SERVICES WEEK

Roger Harmon, the County Judge for Johnson County, Texas and the Commissioners of all four Johnson County Precincts congratulated County EMS personnel for outstanding dedication in medical care to the people of Johnson County and joined the Texas Department of Health in designating the month of May as Trauma Awareness Month. The Court designated May 17th through the 23rd, 1998, as Emergency Medical Services Week in Johnson County.
