Detective Steve Shaw spoke in reference to Chapter 343 of the Texas Health & Safety Code, the premises located at 3512 CR-607, Alvarado, Texas 76009, has been identified as a public nuisance and JP Morgan Chase Bank (c/o WHHGP Management, LLC) has been identified as the person responsible for causing or maintaining a public nuisance on the premises. Detective Shaw said his first response to this property was on September 15, 2010 and at that time found an abandoned, double-wide mobile home on the property. The property was overgrown with grass and weeds and had piles of debris on it and Detective Shaw thought this condition would attract and/or harbor mosquitoes, rats, rodents and other pests. Photographs were taken of the property. Detective Shaw checked with Central Appraisal District and determined the property was not part of a platted subdivision but according to the law, if the property is immediately adjacent to and/or contiguous to a platted subdivision, then it is part of a neighborhood. Therefore, the law does apply to this property because it is next to a platted subdivision. Notice of Violation letters were sent to JP Morgan Chase Bank in New York City and to their registered agent, WHHGP Management, LLC in Houston and they were given a 45 day abatement period. Detective Shaw revisited the property on November 4, 2010 and no work had been done on the property and at that time Notice of Nuisance letters were sent to both locations again, stating today's date as the date for the public hearing. Detective Shaw returned

to the property on December 17, 2010 and found that someone had mowed a 20 foot perimeter around the house itself, but the remainder of the property was left in the overgrown condition and the pile of debris was still on the porch. This property is not in compliance with the law so it is being presented today along with photographs of the property. The hearing was closed at 9:15 A.M.
