Detective Steve Shaw spoke in reference to Chapter 343 of the Texas Health & Safety Code, the premises located at **6001 Short Cake Ln., Joshua, Texas 76058, Johnson County, Texas,** has been identified as a public nuisance and **HSBC Mortgage Services** has been identified as the person responsible for causing or maintaining a public nuisance on the premises. This case began in May 2011 with the first inspection of the property on June 17, 2011. The property has overgrown grass and weeds that could harbor mosquitoes, rats and other pests and a small amount of debris. Det. Shaw checked with Central Appraisal District and determined the owners to be Douglas and Denise Chaney, with certified Notice of Violation letters sent to the Chaney's. The Chaney's sent back notification that the property was not theirs and ownership had gone back to HSBC Mortgage. Notices of Violation letters were sent certified mail to HSBC Mortgage without any response during the 45 day abatement period. Det. Shaw was able to get a

telephone number for HSBC Mortgage and spoke with Maria Vadney and she asked Det. Shaw to send the notices to her and she would hand walk the notices to the proper offices. Notices of Violation letters were sent out, again without any response during the 45 day abatement period. A certified letter was mailed to HSBC Mortgage informing them of the hearing date. The property was inspected again on November 17, 2011 and the property still had not been abated. The hearing was closed at 9:32 A.M.
