COMMISSIONER'S COURT

BE IT KNOWN that on the 27th day of March, 2013, the Honorable Commissioner's Court of Johnson County, Texas, met in Emergency Session at the Courthouse thereof, in the City of Cleburne, Johnson County, Texas, for the purpose of transacting any and all business that may lawfully be brought before the same. The meeting was called to order at 9:00 A.M., with all members present, and the following items, having been lawfully posted and filed for record in the Office of the County Clerk on March 26, 2012 at 5:00 P.M., were considered:

BE IT KNOWN that Commissioner's Court met in Executive Session at 9:05 A.M. in accordance with Government Code *Sec. 551.074*, Personnel, Deliberations Regarding Appointment of Temporary Indigent Health Care Director, Holly Morris, Position #F46-001, Budget Coordinator, County Judge's Office.

The Commissioner's Court reconvened into Open Session at 10:12 A.M. to consider the following:

I. ACTION

1. CONSIDERATION OF RESIGNATION OF RACHAEL SMITHEY-
ASSISTANT ADMINISTRATOR, INDIGENT HEALTH CARE

Comm. Stringer, seconded by Comm. Howell, made a motion to approve to accept the resignation of Rachael Smithey, Assistant Administrator, Indigent Health Care, who resigned March 26, 2013.

All voted aye; motion carried.

2. CONSIDERATION OF ELIMINATING POSITIONS FOR THE INDIGENT HEALTH CARE OFFICE

- a. Administrator-A02-001
- b. Assistant Administrator-F39-001

Comm. Bailey, seconded by Comm. Beeson, made a motion to approve of eliminating positions for the Indigent Health Care Office, Administrator-A02-001 and Assistant Administrator-F39-001.

All voted aye; motion carried.

3. CONSIDERATION OF CREATING TWO CASE WORKER POSITIONS AND POSTING OPEN POSITIONS FOR THE INDIGENT HEALTH CARE OFFICE

- a. Caseworker-IHC F52-001
- b. Caseworker-IHC F52-002

Comm. Stringer, seconded by Comm. Beeson, made a motion to approve of creating two [Case Worker Positions](#), Caseworker-IHC F52-001 and Caseworker-IHC F52-002 and posting open positions for the Indigent Health Care Office at Grade 11 with a salary range for that grade of \$25,048.00 to \$48,186.00 per year, but will be advertised and budgeted at the range of \$30,000.00 to \$35,000.00 per year for those two positions.

All voted aye; motion carried.

4. CONSIDERATION OF TEMPORARY USE OF INDIGENT HEALTHCARE SOLUTIONS EMPLOYEE

Comm. Beeson, seconded by Comm. Stringer, made a motion to approve to accept the offer of temporary use of Indigent Healthcare Solutions Employee with the length of time for the use of the temporary employee to be determined by Indigent Healthcare Solutions.

All voted aye; motion carried.

II. EXECUTIVE SESSION

1. Government Code:

- a. *Sec. 551.074-Personnel-Deliberations Regarding Appointment of Temporary Indigent Health Care Director - Holly Morris-Position #F46-001 – Budget Coordinator, County Judge’s Office*

Comm. Beeson, seconded by Comm. Bailey, made a motion to approve to appoint Holly Morris, Position #F46-001, Budget Coordinator, County Judge’s Office as the Temporary Indigent Health Care Director, with a supplement of \$1,000.00 per month paid to Holly Morris for as long as she remains the Temporary Indigent Health Care Director, she is to remain in her current position as Budget Coordinator for Johnson County and these changes are to be effective immediately.

All voted aye; motion carried.

There being no further business before the Court concerning this agenda, Commissioner’s Court adjourned at 10:38 A.M.
