JOHNSON COUNTY DEPOSITORY PLEDGE CONTRACT

STATE OF TEXAS §

COUNTY OF JOHNSON §

KNOW ALL MEN BY THESE PRESENTS THAT First Financial Bank, N.A., (located in Cleburne, Texas) organized under the laws of the United States, authorized to conduct banking business at its office in JOHNSON COUNTY, TEXAS, hereinafter called "BANK", does hereby pledge and deposit the following securities with Johnson County, Texas hereinafter called "COUNTY" in the amount to be the minimum market values of one hundred and ten percent (110%) of all COUNTY deposits upon the terms and conditions and for the purposes hereinafter set forth:

The conditions of the above contract are such that, whereas, the above BANK was on the 13th day of May, A.D. 2013, duly and legally chosen by the Commissioners Court of Johnson County, Texas, as County Depository for said COUNTY for a period of four (4) years ending sixty days from the time fixed by law for the next selection of a depository, upon its bidding and agreeing pay COUNTY at the rates of interest specified in First Financial Bank, NA.'s Depository Bid dated April 23, 2013.

NOW, THEREFORE, if the above bounden pledgor BANK shall faithfully do and perform all the duties and obligations devolving on it by law as the County Depository of COUNTY, and shall upon presentation pay checks drawn on it by the County Treasurer of COUNTY; on "demand deposits" accounts in such depository; and all checks after the expiration of the period on notice required in the case of "time deposits" and shall faithfully keep said COUNTY funds, and account for same according to law, and shall faithfully keep and account for all funds belonging to the COUNTY which are deposited with it under the requirements of Chapter 116 of the Texas Local Government Code, and shall pay the interest at the time and at the rate hereinbefore stipulated on "time deposits"; and shall at the expiration of the term for which it has been chosen, turn over to its successor all the funds, property, and other things of value, coming into its hands as depository, then and in that event this contract is to be and become null and void, and the securities above shall be returned to the pledgor.

Should the BANK fail at any time to pay and satisfy, when due, any check, draft, or voucher lawfully drawn against any deposit and the interest on such deposits or in any manner breach its contract with COUNTY, the Commissioners court of Johnson County shall give written notice of such failure or breach and the BANK shall have three (3) days to cure such failure or breach within three (3) days or is declared insolvent by a Federal bank regulatory agency, it shall be the duty of the Frost National Bank, San Antonio, Texas, upon demand of the Commissioners Court of Johnson County (supported by proper evidence of any of the above listed circumstances), to surrender the above described collateral to the COUNTY. The Commissioners Court of Johnson County, Texas is hereby authorized to sell at public or private sale to the highest bidder therefore cash, with two (2) hour notice to the pledgor, the securities, or any part thereof, and shall apply the proceeds of sale to the satisfaction of any indebtedness arising by the virtue of the violation of any or all the conditions of this contract.

COUNTY and BANK shall have the right to bid at such sale.

The above provision is given in addition to any remedy the pledge may have in any suit brought on this contract in any court in this State.

Any suit arising out of or in any way connected with this contract shall be tried in the state districts courts of Johnson County, Texas or the federal districts courts of Dallas County, Texas.

First Financial Bank, N.A.'s Depository Bid for Johnson County dated April 23, 2013, including all exhibits and addenda thereto, is incorporated herein by reference as if recited herein verbatim.

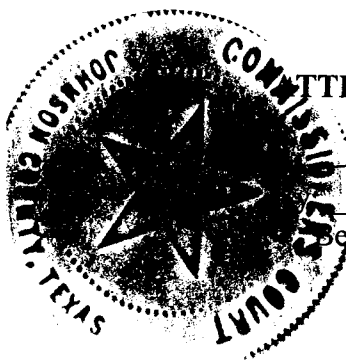

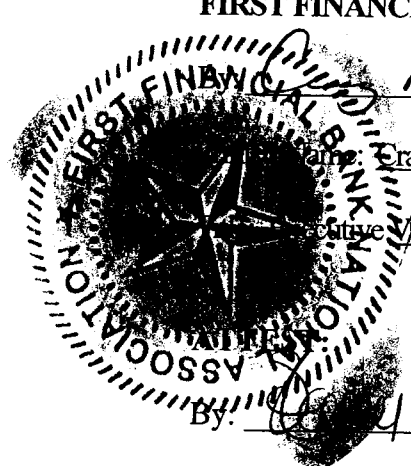
