BE IT KNOWN that on the 27th day of April, 2015, the Honorable Commissioners Court of Johnson County, Texas, met in Regular Session at the Johnson County Courthouse thereof, in the City of Cleburne, Johnson County, Texas, for the purpose of transacting any and all business that may lawfully be brought before the same. The meeting was called to order at 9:24 A.M., with all members present, and following the Invocation led by County Judge, Roger Harmon, and the Pledge of Allegiance, the following items, having been lawfully posted and filed for record in the Office of the County Clerk on April 23, 2015 at 1:12 P.M., were considered:

County Judge Roger Harmon announced that the areas of Johnson County in Precinct #2 and Precinct #3 received storm damage on Saturday night and areas in Precinct #1 and Precinct #4 received storm damage on Sunday night. Commissioner Bailey, Precinct #1 said there was significant damage in his Precinct, but thankfully no serious injuries or loss of life has been reported. Sheriff Alford said his department lost 1 patrol vehicle and 1 deputy sustained minor injuries.
