ORDER CONTINUING THE DECLARATION OF A LOCAL STATE OF  
DISASTER FOR JOHNSON COUNTY, TEXAS

---

WHEREAS, the County of Johnson on the 26<sup>th</sup> day of April, 2015 suffered widespread or severe damage, injury, or loss of life or property (or there was imminent threat of same) resulting from eight confirmed tornadoes; and

WHEREAS, the Judge of the County of Johnson determined that extraordinary measures needed to be taken to alleviate the suffering of people and to protect or rehabilitate property; and

WHEREAS, a local state of disaster was declared for Johnson County, Texas by the County Judge on May 6, 2015; and

WHEREAS, the County's Emergency Management Plan has been implemented; and

WHEREAS, this local state of disaster will continue for a period of not more than seven days from the date of May 6, 2015, unless the same is continued by consent of the Commissioners Court of Johnson County, Texas.

THEREFORE: A motion was made by Commissioner Rick Bailey and seconded by Commissioner Larry Woolley that: "The Commissioners Court approve continuing the declaration of a local state of disaster for Johnson County, Texas that was declared by the County Judge on May 6, 2015."

Said motion was approved by a vote of the Commissioners Court on the 11<sup>th</sup> day of May, 2015.

**NOW THEREFORE BE IT RESOLVED AND ORDERED:**


