COMMISSIONERS COURT GRANTING AN EXEMPTION UNDER SECTION 262.024, LOCAL GOVERNMENT CODE, FROM THE BIDDING REQUIREMENTS OF SECTION 262.023, LOCAL GOVERNMENT CODE, UPON A FINDING THAT THE INVESTMENT AND MANAGEMENT OF JOHNSON COUNTY'S PUBLIC FUNDS IS A PROFESSIONAL SERVICE

The Johnson County Commissioners Court met on May 26, 2015 in regular session for the consideration of representation with First Financial Trust & Asset Management Company, N.A. for the investment and management of Johnson County's public funds. The Commissioners Court finds that this representation is for a professional service and that the Commissioners Court may grant an exemption under Section 262.024, Local Government Code, from the competitive bidding requirements of Section 262.023, Local Government Code.

A motion was made by Commissioner Rick Bailey and seconded by Commissioner Kenny Howell that: "The Commissioners Court find the representation with First Financial Trust & Asset Management Company, N.A. for the investment and management of Johnson County's public funds is a professional service and that the Commissioners Court grant an exemption under Section 262.024, Local Government Code, from the competitive bidding requirements of Section 262.023, Local Government Code, and enter an order to that affect, and that the Commissioners Court approve the representation with First Financial Trust & Asset Management Company, N.A. for the investment and management of Johnson County's public funds.


Said motion was approved by unanimous vote of the Commissioners Court on the 26th day of May, 2015.

NOW THEREFORE BE IT RESOLVED AND ORDERED:






