COMMISSIONERS COURT GRANTING AN EXEMPTION UNDER SECTION 262.024, LOCAL GOVERNMENT CODE, FROM THE BIDDING REQUIREMENTS OF SECTION 262.023, LOCAL GOVERNMENT CODE, UPON THE COMMISSIONERS COURT FINDING THAT THE REPRESENTATION BY BETTYE LYNN OF LYNN, ROSS, GANNAWAY & CRANFORD, L.L.P. IS FOR A PROFESSIONAL SERVICE

The Johnson County Commissioners Court met on June 22, 2015 in a regular session for the consideration of representation by Bettye Lynn of Lynn, Ross, Gannaway & Cranford, L.L.P. The Commissioners Court finds that this representation is for a professional service and that the Commissioners Court may grant an exemption under Section 262.024, Local Government Code, from the competitive bidding requirements of Section 262.023, Local Government Code.

A motion was made by Commissioner Jerry Stringer and seconded by Commissioner Kenny Howell that: "The Commissioners Court find the representation by Bettye Lynn of Lynn, Ross, Gannaway & Cranford, L.L.P. is for a professional service and that the Commissioners Court grant an exemption under Section 262.024, Local Government Code, from the competitive bidding requirements of Section 262.023, Local Government Code, and enter an order to that affect, and that the Commissioners Court approve the representation by Bettye Lynn of Lynn, Ross, Gannaway & Cranford, L.L.P.


Said motion was approved by a vote of the Commissioners Court on the 22nd day of June, 2015.


