This 2nd day of April, 1945, it appearing to the court that June 14, 1914, there was filed in Volume 179, page 642, Deed Records of Johnson County, the plat of a tract of 20 acres of the H. R. Craig Survey, situated outside the corpo ate limits of the Caty of Cleburne, as Morgan's Fourth Addition to the City of Cleburne, and that the streets therein indicated have not been opened or used by the public, and the tract of land has remained enclosed and has been farmed as a while, and that the streets have not been accepted as public streets or roads by this court and would not be of any value or use to the Public, it is therefore ordered that said streets be and the same are hereby abandoned as public streets or roads.
