It is ordered by the Commissioners' Court of Johnson County that the sum of \$1400.00) Fourteen hundred be appropriated and the same is hereby appropriated out of the funds of the county to be used as part salary for a County Home Demoonstration Agent, to be assigned to work in this County by the Extension Service of the Agricultural and Mechanical College of Texas.

This appropriation shall become available on Jan. 1, 1946, or as soon thereafter as the Extension Service of the A. and M. College of Texas shall place an agent in said county for duty, and shall be paid out in monthly installments to said agent upon written order duly signed by an authorized representative of said Extension Service.

This appropriation shall be continuous annually until the Commissioners' Court or the Extension Service of the A. and M. College of Texas shall decide to discontinue same, and the order of discontinuance shall be passed only during the month of September, which time will be near the close of the season and the year's work. Otherwise this order and agreement shall remain in effect from year to year. The Commissioners' Court or the Extension Service of the A. and M. College of Texas shall give notice in writing to the other cooperating agency at least thirty days prior to any official action pertaining to the discontinuance of the work in the county and set a date for a joint hearing. In the event the work is discontinued, the order shall not be effective until thirty days after the date of its passage.
