A motion was made by Commissioner Maddox, seconded by Commissioner Evans that the Warehouse Bond of the Alvarado warehouse Company in the amount of \$5000.00 payable to the State of exas be approved. All voted age.

A motion was made by Commissioner Coward, seconded by Commissioner Roland that the public weighers Bond in the amount of \$2500.00 of Alford J. Jackson payable to the State of Texas be approved. (Precinct No. 1) All voted aye.

A motion was made by Commissioner Roland, seconded by Commissioner Evans that the resignation of F. L. Crow as Justice of the Peace in Justice Precinct No. 4, Johnson County, be and is hereby accepted effective November 14, 1949. All voted age.

A motion was made by Commissioner Evans, seconded by Commissioner Coward that the Election returns for the special election held November 8, 1949 were convassed and tabulated showing County Wide results as follows:
