The Public Hearing will be conducted on Monday, November 9, 2009, at 9:00am, at the Commissioners Court Room, Johnson County Courthouse, 2 North Main St., Cleburne, Texas 76033.

Sec. 234.033. LOCATION OF SLAUGHTERER. The commissioners court of the county may prohibit the operations of a slaughterer:

- (1) within 1,000 feet of a school or residence; or
- (2) at any other location if the commissioners court finds that the operation of a slaughterer's business is incompatible with the existing land use of the neighboring area or would impose an undue hardship on persons residing or trading in the neighboring area.

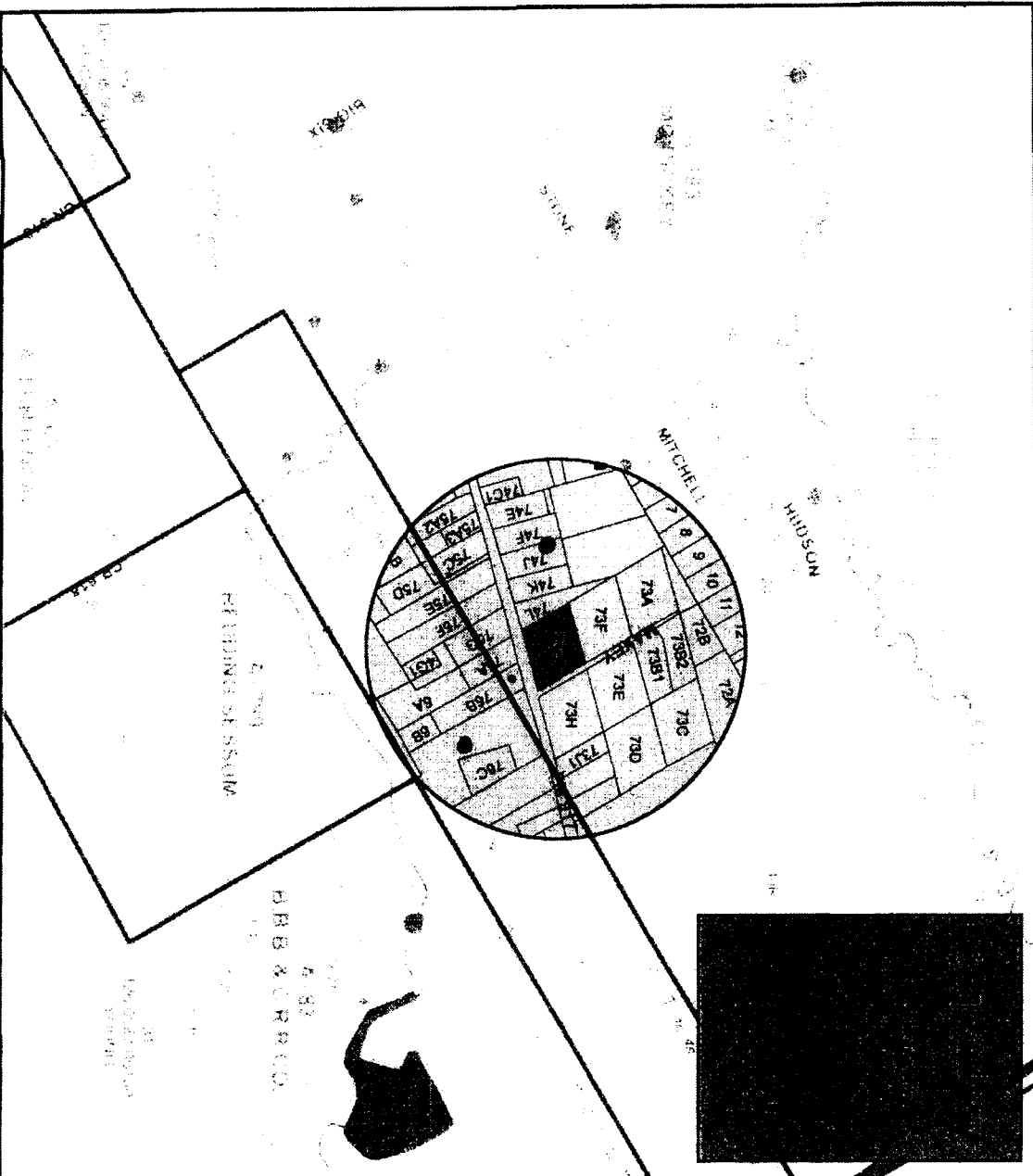



As an employee of a business located in Johnson County, I am writing to express my concerns regarding the proposed slaughterhouse/meat processing operation on Maxey Road.

Historically, slaughterhouses and meat processing operations have an extremely detrimental effect on the surrounding environment. Contaminated wastewater is a common issue with slaughterhouses, not to mention the air pollution produced by these facilities.

The occurrence of *Campylobacter jejuni* is becoming more and more commonplace in slaughterhouses. *C. jejuni* is quickly becoming the leading cause of food-borne pathogens, and is linked to a number of human illnesses; it is present in the majority of slaughterhouses, so consumption of contaminated food isn't necessary to be affected.

In a study in 2007, even the final product of slaughterhouse wastewater treatment plants - in other words, *after treatment, to be used for drinking* - contained high levels of integron-carrying bacteria. These bacteria are inserted into DNA and result in viruses and diseases that are resistant to antibiotics.

The issues I mention are only a tiny part of the health and environmental impact of a slaughterhouse, and doesn't even address aesthetic concerns. While I don't live in Johnson County, I spend a minimum of eight hours each day, five days each week breathing the air and drinking the water here. I have grave concerns for the health and safety of everyone in this area should this proposed slaughterhouse be approved.

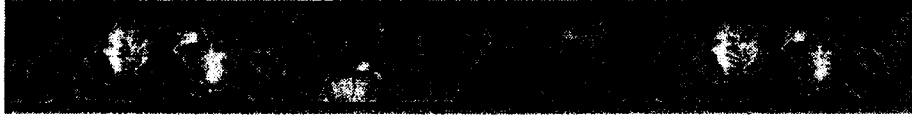

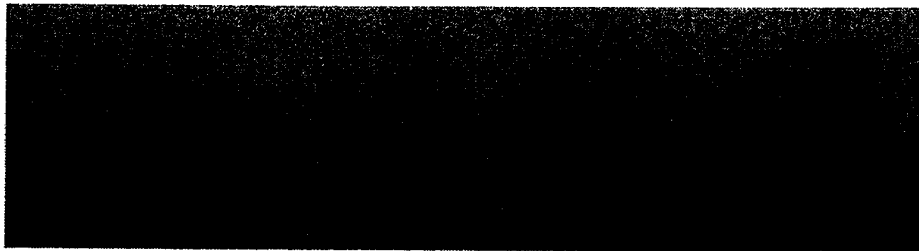

I have lived in and around 917 for more than five years now. The very thing that draws me to the area, the slaughterhouse will take away. If you have been to this area yourself sir, you will notice it is mainly residential. Who is their right mind would place a business like that near all these homes and families? I am willing to bet YOU do not live anywhere near here where this is disease infested, loud, stinking, polluting slaughterhouse is going to be. Well, I don't want in my view or neighborhood either. Johnson county is a large area. A lot of it open. Surely there is a more suitable place.
