Jail Flooring Project Background Information 05-17-2013

The project to remove & replace an area of tile flooring in the dishwashing area at the jail was approved by the Commissioners' Court on 3-25-13, for an amount of \$6,572.00. However, the contractor ran into an unknown issue once they removed the existing tile flooring. This area has a drain in the middle of the floor that the water must slope down to. After removing the tile it was found that there were drains along the perimeter of the room which was for clothes washing machines, and the original floor sloped toward those perimeter drains. The contractor had to bring in additional concrete etc. in order to make the floor slope back toward the drain in the middle of the floor.

It would not have been a good idea for the contractor to wait for an authorization to do the extra work involved, it just had to be done. All of his work needed to be done very quickly so as to avoid interrupting their operations. You can look at his invoice for a more detailed description of the reason for the additional work and the amount. I recommend payment of this invoice in the amount of \$1,000 for the additional work.
