**INTERLOCAL AGREEMENT FOR:
City Of Alvarado and Johnson County Precinct #3**

This agreement is made and entered into pursuant to Chapter 791, Government Code, Vernon's Texas Code Annotated, on the 12th day of August, 2013, by Johnson County, Texas, through its Commissioner's Court and the City of Alvarado for the purpose of road repair as required in Johnson County, Texas and within the corporate limits of Alvarado, Texas and shall terminate on September 30, 2013.

1. Therefore the parties agree as follows: Johnson County Precinct #3 will perform road work on approximately 840 feet of County Road 508 within the city limits of Alvarado, Texas. Construction of the roadway will consist of the application of a second course of seal coat on the road surface. Building up of road shoulders is not included. Payment to Johnson County Precinct #3 will be in the amount of \$4470.25 as itemized in the attached Schedule of Costs for Precinct Services (see Attachment A);

2. Payment of total charges for this Agreement is due and payable within Thirty (30) days of receipt of an invoice for said amount from Johnson County, Texas.

3. Any unpaid balance remaining after thirty (30) days from receipt of invoice shall earn interest at the maximum interest rate per annum allowed by law until paid.

4. Payment under this Agreement shall be made from current revenues available to the party making payment.

5. All work will be done in a workmanlike manner as measured by Johnson County's usual practice in said work to be performed. Johnson County

shall be in charge of all controls, procedures, means, coordination, and final inspection of the work to be performed pursuant to this Agreement.

6. Nothing herein shall alter or change the legal responsibility under existing law for a party, nor will this Agreement cause Johnson County to incur additional liability other than liability it would have under the law without this Agreement. City of Alvarado agrees, subject to the limitations of the Texas Constitution and the Texas Tort Claims Act, to indemnify and hold harmless Johnson County, its agents, and employees, from all suits, claims, damages, losses, and expenses, including reasonable attorney fees arising out of the County's performance of the work to be performed.
7. This Agreement represents the entire and integrated agreement between Johnson County and City of Alvarado and supersedes all prior negotiations, representations and/or agreements either written or oral. This Agreement may be amended only by written instruments signed by both Johnson County and City of Alvarado.
8. The validity of this Agreement and of its terms or provisions, as well as the rights and duties of the parties hereto, shall be governed by the laws of the State of Texas.
9. In the event that any portion of this agreement shall be found to be contrary to law, it is the intent of the parties hereto that the remaining portions shall remain valid and in full force and effect to the extent possible.
10. This Agreement may be terminated at anytime, by either party giving thirty (30) days advanced notice to the other party. In the event of such termination of either party, Johnson County shall be compensated for the costs of all materials and/or labor performed to termination date as authorized by this Agreement.
11. The undersigned officer and/or agents of the parties hereto are the properly authorized officials and have the authority to execute this Agreement on behalf of the parties hereto, and each party certifies to the other that any necessary resolutions extending said authority have been duly passed and are now in full force and effect.


