DESIGNATION OF VEHICLES EXEMPT FROM INSCRIPTION REQUIREMENTS OF SECTION 721.004 OF THE TEXAS TRANSPORTATION CODE

WHEREAS, pursuant to Section 502.451 of the Texas Transportation Code, a license plate that is issued to the owner of a vehicle that is except by law from the payment of registration fees must bear the word "exempt"; and

WHEREAS, pursuant to Section 502.451(f) of the Texas Transportation Code, a license plate may be issued to the owner of a vehicle that is except by law from the payment of registration fees without the license plate bearing the word "exempt" provided the commissioners court has entered an order as provided by Section 721.005 of the Texas Transportation Code; and

WHEREAS, Section 721.004 of the Texas Transportation Code requires an inscription on all county owned motor vehicles; and

WHEREAS, Section 721.005 of the Texas Transportation Code allows the commissioners court of a county to exempt certain motor vehicles from the requirements of Section 721.004 of the Texas Transportation Code; and

WHEREAS, the commissioners court of Johnson County desires to exempt from the requirements of Section 721.004 of the Texas Transportation Code the vehicles used in the various county offices and departments, including the STOP-Special Crimes Unit, the District Attorney, the County Attorney, the Juvenile Probation Department, and the Johnson County Sheriff's Office (but not pertaining to the Johnson County Sheriff's Office vehicles marked with an inscription), so that the license plates on said vehicles will not bear the word "exempt".

IT IS FURTHER ORDERED, the Purchasing Agent of Johnson County and any designee of the Purchasing Agent shall have the authority to execute all documents pertaining to said vehicles assigned to the offices and departments of Johnson County, Texas.
