- WHEREAS, according to data from the Texas Department of Public Safety, 102 women were killed by an intimate partner in Texas in 2011; and
- WHEREAS, a coalition of organizations in our county work diligently to confront this crisis, including the Johnson County Family Crisis Center, law enforcement, health care providers, churches, and other concerned citizens are helping in the effort to end domestic violence; and
- WHEREAS, survivors of domestic violence themselves have been at the forefront of efforts to bring peace and equality to the home.

NOW THEREFORE, in recognition of the important work done by domestic violence programs, I, Roger Harmon, County Judge of Johnson County, and we the Commissioners of the four Precincts in Johnson County, Texas, do hereby proclaim the month of October 2013 as
