

Johnson County 1913 Courthouse

The 5th and present Johnson County Courthouse was completed November 28, 1913, at a cost of \$184,000.00. The architect was Lang and Mitchell. The specifications of this building called for "Texas red granite of the best quality from Burnet County; dark Georgia Eveale marble, highly polished and not less than seven-eighths of an inch thick." The Johnson County Courthouse has walls of matched panels of Georgia Marble. The open rotunda, six stories tall, is supported by four columns of matched marble. The ornates are made of plaster and finished in old ivory and gold. The sides of the dome are stunning designs in stained glass, on top of which is a majestic old clock. The atrium is considered among the great interior spaces of Texas.

Johnson County received a 4 Million Dollar Grant from the Texas Historical Commission which the Commissioners Court matched totaling an 8 Million Dollar Project to restore the Courthouse beginning in December of 2004. The architect on the project was Luchi-Texas, Inc. and the contractor was Skawson, Walker & Skemper. Upon completion, the Courthouse was re-dedicated in December of 2007. All of the County's administrative offices moved back into the Courthouse in the spring of 2008 and currently reside in the restored Courthouse.


Texas State Historical Marker 2000
