CLOSING A PORTION OF BRYANT PLACE, PARCEL 457

The Johnson County Commissioners Court met on January 13, 2014 in regular session and held a public hearing to consider "Closing a Portion of Bryant Place" where Bryant Place intersects Highway 121 due to the construction of Highway 121 and said portion of Bryant Place to be closed is identified as Parcel 457 by the North Texas Tollway Authority.

The Public Hearing was properly posted twenty (20) days prior at the bulletin board of the Johnson County Commissioners Court at the County Courthouse and at each end of the said road being two public places in the vicinity of the aforesaid road. Notice was also published in the Cleburne Times Review on January 5, 2014.

A motion was made by Commissioner Howell and seconded by Commissioner Beeson to approve the closure of a portion of County Bryant Place where Bryant Place intersects Highway 121 due to the construction of Highway 121 and said portion of Bryant Place to be closed is identified as Parcel 457 by the North Texas Tollway Authority. Said motion was approved by a unanimous vote of the Commissioners Court.


**NOW THEREFORE BE IT RESOLVED AND ORDERED:**





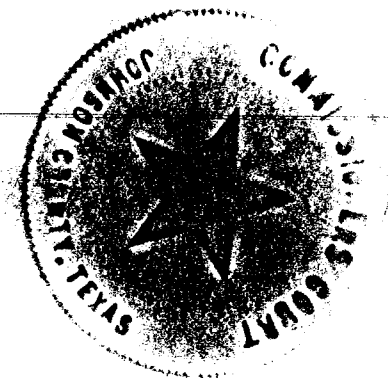

**LEGAL DESCRIPTION**

ALL THAT CERTAIN TRACT OR PARCEL OF LAND SITUATED IN THE JOSEPH WEST SURVEY, ABSTRACT NO. 855, JOHNSON COUNTY, TEXAS, BEING A PORTION OF BRYANT PLACE, BRUSHY NOB ADDITION, AN ADDITION TO JOHNSON COUNTY, AS RECORDED IN VOLUME 1, PAGE 103, PLAT RECORDS, JOHNSON COUNTY, TEXAS, BEING MORE PARTICULARLY DESCRIBED BY METES AND BOUNDS AS FOLLOWS:

BEGINNING AT A 5/8" BAR WITH ALUMINUM CAP STAMPED "TEXAS DEPARTMENT OF TRANSPORTATION" FOUND AT THE SOUTHWEST CORNER OF THAT CERTAIN TRACT OF LAND DESCRIBED IN DEED TO STATE OF TEXAS, AS RECORDED IN VOLUME 3595, PAGE 359, DEED RECORDS, JOHNSON COUNTY, TEXAS, SAID POINT BEING AT A RIGHT ANGLE TO CENTERLINE SURVEY STATION 1499+06.26 OF STATE HIGHWAY NO. 121;

THENCE ALONG THE NORTH RIGHT OF WAY LINE OF BRYANT PLACE NORTH 89 DEGREES 49 MINUTES 41 SECONDS EAST A DISTANCE OF 323.96 FEET TO THE BEGINNING OF A CURVE CONCAVE NORTHWESTERLY HAVING A RADIUS OF 77.18 FEET;

THENCE CONTINUING ALONG SAID NORTH LINE AND SAID CURVE THROUGH A CENTRAL ANGLE OF 83 DEGREES 10 MINUTES 23 SECONDS, AN ARC LENGTH OF 112.03 FEET, BEING SUBTENDED BY A CHORD BEARING NORTH 47 DEGREES 17 MINUTES 34 SECONDS EAST A DISTANCE OF 102.45 FEET TO A 1/2" REBAR WITH ALUMINUM CAP STAMPED "MLA RPLS 4873" SET;

THENCE SOUTH 09 DEGREES 41 MINUTES 00 SECONDS EAST A DISTANCE OF 94.77 FEET TO A 5/8" BAR WITH ALUMINUM CAP STAMPED "TEXAS DEPARTMENT OF TRANSPORTATION" FOUND AT THE NORTHEAST CORNER OF THAT CERTAIN TRACT OF LAND DESCRIBED IN DEED TO STATE OF TEXAS, AS RECORDED IN VOLUME 4471, PAGE 625, DEED RECORDS, JOHNSON COUNTY, TEXAS, SAID POINT BEING ON THE SOUTH RIGHT OF WAY LINE OF SAID BRYANT PLACE, SAID POINT ALSO BEING THE BEGINNING OF A CURVE CONCAVE NORTHWESTERLY HAVING A RADIUS OF 137.18 FEET;

THENCE ALONG SAID SOUTH LINE AND SAID CURVE THROUGH A CENTRAL ANGLE OF 41 DEGREES 24 MINUTES 38 SECONDS, AN ARC LENGTH OF 99.15 FEET, BEING SUBTENDED BY A CHORD BEARING SOUTH 68 DEGREES 10 MINUTES 17 SECONDS WEST A DISTANCE OF 97.00 FEET;

THENCE CONTINUING ALONG SAID SOUTH LINE SOUTH 89 DEGREES 49 MINUTES 41 SECONDS WEST A DISTANCE OF 307.11 FEET TO A 5/8" BAR WITH ALUMINUM CAP STAMPED "TEXAS DEPARTMENT OF TRANSPORTATION" FOUND AT THE NORTHWEST CORNER OF THAT CERTAIN TRACT OF LAND DESCRIBED IN DEED TO STATE OF TEXAS, AS RECORDED IN INSTRUMENT NO. 12334, DEED RECORDS, JOHNSON COUNTY, TEXAS;

THENCE NORTH 18 DEGREES 44 MINUTES 07 SECONDS WEST A DISTANCE OF 62.60 FEET TO THE POINT OF BEGINNING, CONTAINING 24,936 SQUARE FEET OR 0.572 ACRE OF LAND, MORE OR LESS.

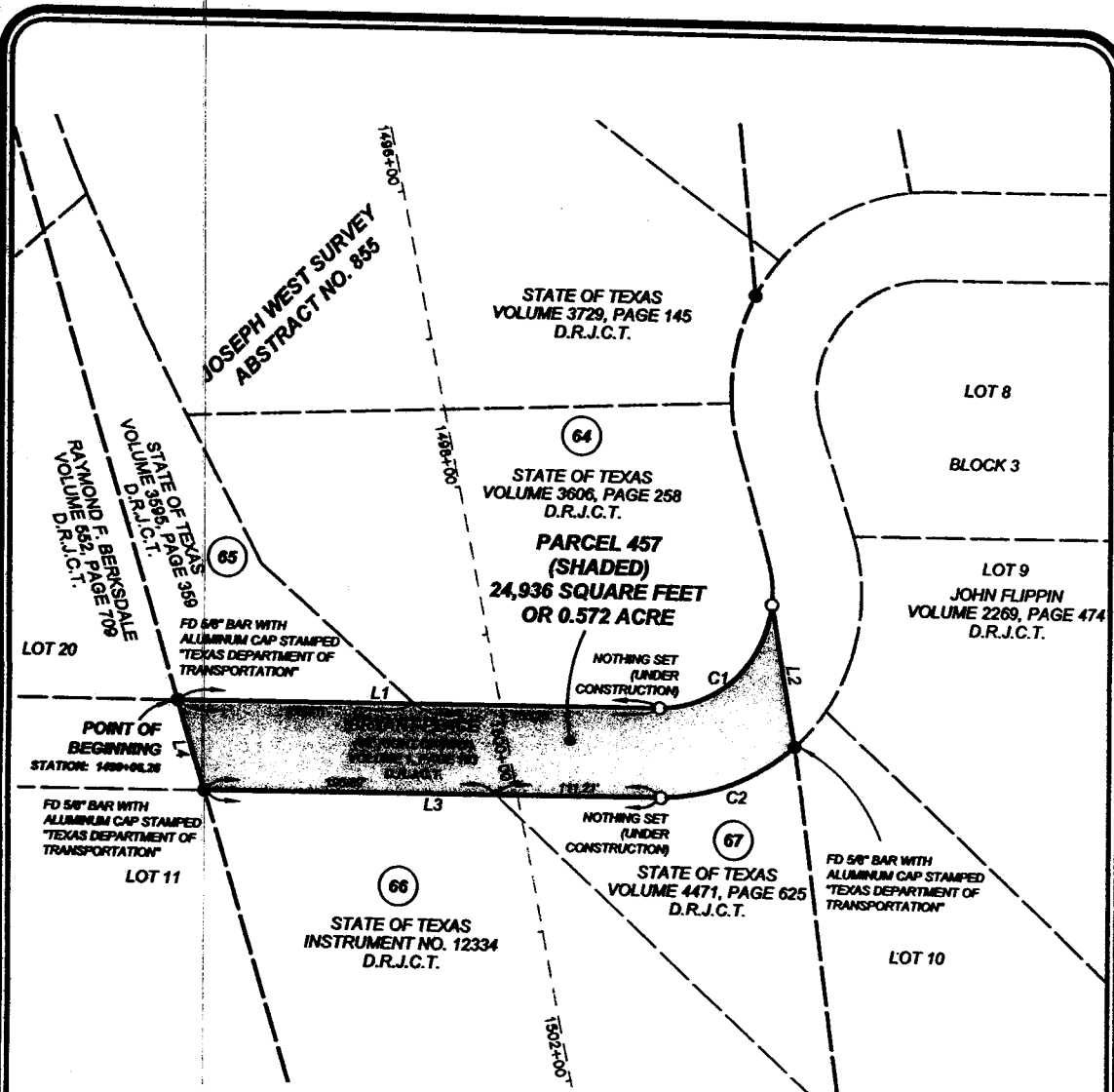

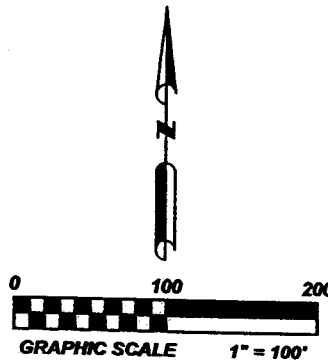
