CLOSING A PORTION OF COUNTY ROAD 1015, PARCEL 403A

IT IS FURTHER ORDERED THAT pursuant to Section 251.058, Texas Transportation Code, Parcel 403A is conveyed to the Animal Pancakes, L.L.C. whose mailing address is 2518 El Greco Cove, Austin, Texas 78703 and said Parcel 403A is a 0.181 acre tract, more or less, and more particularly described in Exhibit "A" which is attached hereto and incorporated fully as if recited herein verbatim.
