The proposed fee schedule eliminates fees no longer used:

- Real Estate Inspection on permitted system
- Septic Rule Book
- Gated Subdivision Rules Book

Changes to fee schedule include:

- Re-inspection Fee changed from \$175 to \$200
- Land Development Book from \$7.20 to \$10

New Fees proposed:

- Development Accessory Building Permits (NOT a HOME)
 - This would be for barns, garages, shops and any large building that does not have living quarters (septic). Fees would be waived for carports, pole barns and smaller buildings (299 sq. ft. or less).
- Cancellation of Subdivision
- Abandon Road(s)
- Variance Request (when not doing a re-plat)
- Release of Easement (when not doing a re-plat)

Copies changes:

- 18" X 24" would now be \$3.50 instead of \$3.30 a page
- Aerial photos are removed
