**AMENDMENT TO ORDER # 2012-19 REGARDING IMPOSITION OF  
OPTIONAL COUNTY FEE FOR CHILD SAFETY PURSUANT TO SECTION  
502.403 OF THE TEXAS TRANSPORTATION CODE**

The Johnson County Commissioners Court met on August 11, 2014 in regular session for the purpose of considering amending Order #2012-19 regarding the imposition of an optional county fee of not more than \$1.50 for registering a vehicle in Johnson County, Texas pursuant to Section 502.403 of the Texas Transportation Code. The revenue from the fee may be used only for a purpose permitted by Article 102.014 (g) of the Texas Code of Criminal Procedure which is to provide school crossing guard services and programs designed to enhance child safety, health, nutrition, including child abuse prevention and intervention and drug and alcohol abuse prevention. Johnson County may deduct administrative costs in the amount of ten percent of the revenue received from the optional fee to be deposited into the general revenue fund of Johnson County.

A motion was made by Commissioner Jerry Stringer and seconded by Commissioner Kenny Howell approving an amendment to Order #2012-19 regarding the imposition of an optional county fee in the amount of \$1.50 for registering a vehicle in Johnson County pursuant to Section 502.403 of the Texas Transportation Code and for Johnson County to deduct administrative costs in the amount of ten percent of the revenue received from the optional fee to be deposited into the general revenue fund of Johnson County and to provide that after deducting ten percent of the revenue from the fee, one-third (1/3) of the remaining optional fee is to be paid to the Children's Advocacy Center of Johnson County, one-third (1/3) of the remaining optional fee is to be paid to CASA of Johnson County, and one-third (1/3) of the remaining optional fee is to be paid to the Family Crisis Center of Johnson County which the Commissioners Court finds are organizations that have programs designed to

enhance child safety, health, nutrition, including child abuse prevention and intervention and drug and alcohol abuse prevention.

**NOW THEREFORE BE IT RESOLVED AND ORDERED:**

The Commissioners Court of Johnson County, Texas does hereby enter this Order #2014-37 which amends Order #2102-19 regarding the imposition of an optional county fee in the amount of \$1.50 for registering a vehicle in Johnson County, Texas pursuant to Section 502.403 of the Texas Transportation Code.

It is further Ordered that Johnson County deduct administrative costs in amount of ten percent of the revenue received from the optional fee to be deposited into the general revenue fund of Johnson County and that after deducting ten percent of the revenue from the fee, one-third (1/3) of the remaining optional fee is to be paid to the Children's Advocacy Center of Johnson County, one-third (1/3) of the remaining optional fee is to be paid to CASA of Johnson County, and one-third (1/3) of the remaining optional fee is to be paid to the Family Crisis Center of Johnson County which the Commissioners Court finds are organizations that have programs designed to enhance child safety, health, nutrition, including child abuse prevention and intervention and drug and alcohol abuse prevention.
